The comment will point out that fillers, which could be described as a limiting of organic material are used in resilient floor coverings not to improve reaction to fire but for product performance purposes.

Jane Gardner was informed that Plastic Recyclers Europe (PRE) does not agree with ERFMI's definition of preconsumer waste. PRE considers it as "by-products", which do not count for Recovinyl 2.0 and future recycling quotas in products. Recycling vs. waste disposal and ERFMI's internal waste circles are discussed, and the participants agree to illustrate ERFMI's definitions of pre- and post-consumer waste with practical examples. A separate call on this topic will be arranged.
