

EU Sustainable products strategy

- Products placed on the market should be designed in such a way that they
 - o have a longer service life
 - o easier to reuse, repair and recycle; and
 - contain the highest possible proportion of recycled materials replacing primary raw materials
- · Restriction on the use of disposable products
- Action against premature obsolescence
- · ban on the destruction of unsold durable goods
- Sustainable Products Initiative
- Widening the scope of the Ecodesign Directive beyond energy-related products
- Focus on are electronics, ICT, textiles, furniture and high-impact intermediary products such as steel, cement and chemicals
- Further product groups are to be identified based on their environmental impact and circularity potential.

Extended producer responsibility

ERFMI position on EPR

ERFMI believes that any Extended Producer Responsibility scheme should follow a harmonized system applicable in the different Member States in coherence with European statutes on products and goods trade, to allow a well-functioning Single Market for construction products across the European Union. Having different schemes in Member States will require considerable adjustments from manufacturers to specific markets and will cause significant additional costs and disruption.

Considerations should include:

- Alignment with regard to rules and guidelines for setting up EPR schemes at national and European level
- Assuring fair competition within Europe for products manufactured in and outside EU within the framework of the circular economy
- Increased enforcement and market surveillance to ensure a level playing field across Europe
- Eco-modulation fees based on criteria rewarding innovation in design for improving the circularity of
 products, based on harmonized definitions and quality criteria across Europe. This could include uptake
 of recycled content, design for disassembly and recycling, availability of collection systems and recycling
 technology.



Brexit



- UKCA marking to replace CE marking for products placed on the market in the UK
- Monitored closely by ERFMI
- Put together document with EUFCA on the implications for flooring
- UK Reach seminar held in February 2021
- Important to keep track of changes/ divergences in EU Construction products regulations and UK Construction products regulations
